

## AMNESTY ON RENEWAL OF CERTIFICATION

Q1: WHO CAN AVAIL OF THE AMNESTY?

A: Only those who were issued certificates as Certified Tax Technicians (CTT) but such certifications have expired either in 2021, 2022 or 2023.

Q2: ARE PASSERS IN THE PREVIOUS YEARS WHO FAILED TO REGISTER (AND THE RESULT HAVE ALREADY EXPIRED) ELIGIBLE TO AVAIL OF THE AMNESTY?

A. No. They were not previously issued certificates as Certified Tax Technicians.

Q3: WHAT ARE THE REQUIREMENTS FOR THE AVAILMENT OF THE AMNESTY?

They are the following:

- (a) Must have registered and attended at least two (2) complete tax seminars sponsored by the PACTT / Certified Tax Practitioners;
- (b) Must have paid an Amnesty/Renewal Fee of One Thousand Pesos (P1,000.00) thru any of the following payment channels;

- (c) Must file the Application for Amnesty/Renewal **not later than June 30, 2024** by observing the following procedure:

1. Visit the link: <https://forms.gle/ZFogGiBhHH6hGv4RA>
2. Accomplish the required information. Attach one (1) PDF file only containing all of the following documents in the google form:
  - a. Proof of payment
    - Must include the complete destination account number and date and time.
    - Screenshot of proof of payment. Include Reference Number, if applicable.
  - b. Copy of expired CTT ID card or CTT Certificate.
  - c. Certificates of Attendance in the seminars attended.
  - d. Passport size formal picture (for the issuance of new ID and Certificate)

3. Upon successfully filling-in the google form, kindly wait while we process your application. If there is a problem on your application, you will be contacted by the office.

Q4: WHAT WILL HAPPEN TO THOSE PREVIOUSLY ISSUED CERTIFICATIONS WHO WILL NOT AVAIL OF THE AMNESTY?

A: The certificates have already expired. Therefore, they cease to become Certified Tax Technicians.
