After submitting your application, please allow **2–4 months** to receive your rating, ID card, sling bag, and certificates. Applications will be processed on a **first-come, first-served basis**.

If your location cannot be reached by courier, we will contact you via **mobile phone**. Kindly respond promptly.

6. **Membership Renewal and Benefits:**

- Membership is **renewable every five (5) years**.
- You will be entitled to attend **online seminars** with minimal fees for materials and clerical expenses.
- **Attendance in at least two (2) seminars** within the five-year period is required for membership renewal.
